

Welcome to the world of Miss R. It is a deep and mysterious place. On behalf of the Session Place, we thank you for going thru this application and interview process. This is necessary to ensure that you are compatible in the artistic, therapeutic and educational services offered by Miss R. Before any Session can be scheduled, you must execute the attached Agreement for Services and these Rules of Session, and honestly complete the Questionnaire. You must also show Miss R some legal identifying information (State I.D., Drivers License) so that she can confirm that you are of legal consenting age for the activities and discussions subsequent to this Agreement. Miss R has the absolute right to know who her clients are. If you have any questions about your rights and responsibilities as a Client or the terms and conditions of the Agreement, Miss R will gladly answer your questions, or find out the answer for you. If you are not interested in a Session, or circumstances prohibit you from complying with the stated conditions within the Rules, you should back out prior to executing the Agreement, the Rules and the Questionnaire.

Definitions

The following terms are utilized in the Agreement or the Rules and shall have the meanings as set forth below:

Client - means the person (or persons) whom has executed an Agreement with Miss R and for whom Miss R will provide mutually agreed upon services.

Session - means the one hour (generally) of time during which Miss R will provide mutually agreed upon services. The Client will be under the direction and guidance of Miss R during each Session. Interviews are above and beyond Session time.

Session Place - means the place that the Session will be held. The Session Place location is to be kept strictly confidential by the Client, pursuant to the terms and conditions of the Agreement. Miss R will disclose the location of the Session Place to the Client when She deems it appropriate.

Equipment - means items and products that are to be used during a Session with a Client in an artistic, therapeutic and educational demonstration.

Safe Words/ Signals - means the mutually agreed upon word/s or signals to be used by the Client or Miss R to halt any of the mutually agreed upon Session services for whatever reason.

Techniques - means how to use Equipment and other physical ways as taught by Miss R to be learned by the Client during the Session with Miss R to enhance the Client's personal life with other consenting adults.

Availability of Miss R

To schedule a Session with Miss R, the client must complete the application and interview process and, if Miss R deems the Client to be worthy of her services, the Client will be required to execute the Agreement. Execution of the Agreement does not mean that the Client has unrestricted access to Miss R. Miss R will instruct the Client as to the manner and method of ascertaining her availability for a Session. Miss R requires at least 48 hours prior notice before scheduling a Session because Miss R is busy and will not rearrange her schedule to accommodate the Client. The Client is requested to confirm the appointed time for a scheduled Session the day before the Session. Miss R will not offer Sessions within 24 hours of the execution of the Agreement of Services.

Visits to private residences and offices are very rare and need to be discussed in detail before Miss R will agree. Donation payment in full 24 hours in advance will be required for "Visitations".

If scheduling Sessions becomes a problem (such as overbooking, Miss R's inability to attend a Session, etc.), rescheduling the Session will be Miss R's full responsibility and all efforts will be made to reschedule the Session for the convenience of the Client. If the Client determines that the rescheduled Session availability is not convenient, the Client will be put on a "will call" list for the next available time or cancellation. If the Client cancels the Session with less than 24 hours prior notice to Miss R, Miss R will become very unhappy. Miss R requires full payment of the mutually agreed upon donation and reimbursement for any costs or expenses incurred by the canceling Client PRIOR to rescheduling another Session with the canceling Client.

If the Client wishes to book Miss R for Multiple Sessions on one day or within the same week, this will be on Miss R's convenience and each Session will be assumed to be for separate donations.

Referrals

Referrals to others in the profession will be given freely, but please be aware that each Dominant conducts business differently. A new series of interviews and such may have to happen each time the Client chooses to do business with a different Dominant. Miss R will not share her files with anyone else without the express, written permission of the Client, and only those certain portions that the Client wishes to have known. If a Multiple Dominant Session, or 'Double Dom', is to occur, such information is necessary to be shared to complete the planning of the session. A referral does not constitute the termination of the business relationship with Miss R.

For Couples and More

All of the rules listed in this document applies, but Miss R would like to hold a

separate 'mini-session' with each of the people involved to gauge reactions and limits before a session with both parties. These separate sessions are not part of the interview process, and as such are considered paid sessions. A donation contingent on the couple's session with Miss R will be in effect, so please discuss this with her. If a viewed-only (voyeuristic) couple's session is intended, the separate session with the active participant shall still be required.

Miss R has a policy of only doing sessions at her own space. If a couple, after the individual sessions, feel it would be more appropriate or comfortable to do the session together in their own environment, it should be discussed with Miss R to be considered before the Session is scheduled.

Agreed Upon Services

Miss R requires that the Client discuss their needs for educational, therapeutic and artistic services prior to acceptance as a Client and prior to each scheduled Session. This is necessary to assure compatibility between the parties, although during a Session, Miss R will decide which needs of the Client will be met. Miss R's limits change from Client to Client and Session to Session so the Client must be honest as to expectations and desires.

The Session is intended to educate the Client in an artistic and therapeutic environment by teaching various Techniques and using Equipment to enhance to Client's personal life. Any other implied purposes or activities may be illegal under Wisconsin criminal laws governing prostitution (944.30 Wis. Stats.), and other laws, therefore, such activities will not be tolerated within the Session. If at any time during the Session the Client asks for such activities, the Session will be immediately terminated and the Client will be required to tender any reimbursable costs and expenses to Miss R for the Session.

Any unwanted or inappropriate touch or conduct by the client, including, but not limited to, any attempt to exchange bodily fluids, constitutes reason for immediate termination of the Session and the Agreement by Miss R. At that point, the Client is responsible for full payment and reimbursement for the Session expenses, including any punitive fees required by Miss R. Please be aware that the Client may not be asked back in the future because of this.

Safety Standards

Safety in all areas is of primary importance to Miss R. If the Client has questions about the safety of any mutually agreed upon services, then the Client is instructed to ask Miss R BEFORE the activity commences. The Client is also responsible for stopping a Session by stating the Safe Word/s or using a Safe Signal should any equipment be malfunctioning or breaking, or if they are uncomfortable during a Session (whether physically, emotionally or any other way). Miss R may also, at her

discretion, decide to stop the Session for safety reasons. Injuries to the Client are unintentional. It is the responsibility of the client to avoid injuries by using the Safe Word/s and keeping Miss R informed on the Clients physical and emotional state before and during a Session.

Breakage to Equipment, intentional or not, will be asked to be reimbursed by the Client for disposal and replacement. Occurrence of injuries because of Equipment failure shall refer to the appropriate paragraph as stated. If, during subsequent Sessions, more damage and equipment failure occurs because of actions of the Client, the Client will be asked not to come back.

If the Client wishes to bring equipment of their own to a Session, please discuss this with Miss R beforehand. Taking into account safety and general usability, be aware that Miss R may not use the equipment if it is brought to a Session.

A Questionnaire containing a medical disclosure form will be given before the initial Session which will include questions about the Client's physical, medical and psychological conditions. Failure to complete the Questionnaire accurately will result in termination of the Session and/or Agreement. Miss R will not tolerate the Client jeopardizing their health and Her career during a Session. Any injury to either party during a Session will result in immediate termination of the Session so that the injury can be attended to by appropriate medical personnel.

Arriving at a Session under the influence of alcohol or recreational drugs is completely prohibited and will result in cancellation of the Session and possibly termination of the Agreement with the Client. Miss R will not tolerate intoxicated or inebriated Clients. If the Client is under Physician care that includes medications that are of a mind altering or physically detrimental nature, Miss R will want to know about it before any Sessions, and may not want to schedule any Sessions while the Client is under the influence of those medications.

Post Session Activities

After a Session has been completed, Miss R suggests a cooling off period to discuss with the Client any questions, comments, appreciation, misgivings or plans for future Sessions, if any.

Confidentiality

Miss R expects the Client to maintain complete confidentiality of her non Pro identity, if known or discovered by the Client, and the location of the Session Place from all other persons. Failure to respect this requirement may lead to legal action.

Miss R shall also maintain full confidentiality of the client's identity. Miss R will keep the Client's identity confidential from all other persons, subject to the terms and conditions of the Agreement. The Client may ask to see their file at any time, though

because the files are kept off-site, it may be 48 hours before Miss R can comply with the request.

The Client may terminate the business relationship at any time, as long as it is at an appropriate time, hence right before or during a scheduled Session is not appropriate. The Client shall receive upon termination of the business relationship with Miss R the files she has compiled to date to do with as the Client wills. If the client decides after termination of the business relationship to recontact Miss R, the Client shall have to go thru another interview series and sign another waiver. As part of the termination of the business relationship an 'exit interview' will be requested to be conducted. Partially, it will be held to make sure miscommunications have not been responsible for bad feelings upon the Client's behalf.

The Client acknowledges that the above Rules have been read and understood and agrees to abide by the requirements set forth herein.

AGREEMENT FOR SERVICES

THIS AGREEMENT FOR SERVICES (henceforth referred to as 'the Agreement'), is made and entered into as of _____, _____, between Miss R (professional pseudonym) and _____ (henceforth referred to as 'the Client').

THE PARTIES RECITE THAT:

WHEREAS, Miss R offers services to consenting adults of an artistic, therapeutic and educational nature.

WHEREAS, the Client desires to retain the services of Miss R.

WHEREAS, the parties desire to set forth the terms and conditions under which Miss R may provide such services to the Client.

THE PARTIES HEREBY AGREE AS FOLLOWS:

- 1 - Miss R and the Client each certify that they are of adult legal age according to the laws of the State of Wisconsin.
- 2 - Miss R and the Client will abide by the Rules for Session (henceforth referred to as 'the Rules'), attached hereto and incorporated into this Agreement. Any conflict between the terms and conditions of this Agreement and the Rules will be interpreted for the benefit of Miss R.
- 3 - This Agreement shall be effective upon execution by both parties and is renewable on an as requested basis upon mutual agreement between Miss R and the Client without requiring execution of an additional Agreement. The parties shall remain subject to the terms and conditions of this Agreement and Rules for any and all additional Sessions.
- 4 - An appropriate and mutually agreed upon donation for Miss R's time and services will be paid in cash prior to the commencement of each Session. In addition, reimbursement for any costs and/or expenses related to the Session as requested by the Client is payable by cash prior to the commencement of each Session. Miss R is responsible for any and all Federal, State or Local taxes due to the government authorities.
- 5 - Miss R understands and respects the Client's desire to retain their right to privacy and, as such, Miss R will maintain complete confidentiality of the Client's name, address and any other identifying information or characteristics unless either (a) prior approval has been obtained from the Client, or (b) Miss R must use the information if the Client breaches the terms and conditions of this Agreement. The

Client understands that 'Miss R' is a pseudonym and respects Miss R's desire to retain Her right to privacy under all applicable laws and regulations. In accordance with this term and condition, the Client will maintain complete confidentiality of Miss R's true identity should the Client know or discover it. In addition, the Client will maintain complete confidentiality of the location of the Session Place.

6 - By execution of this Agreement, any Client who is a law enforcement agent and/or government employee, including Postal employee, certifies that they are retaining the services of Miss R solely for personal reasons and not for any reason associated with law enforcement and/or the government. As such, the Client asserts that they are not employed by or working for a governmental agency, or on their own behalf, to use this interview or subsequent interviews or Sessions for entrapment purposes of any sort.

7 - This Agreement may be terminated by Miss R for any reason without prior notice, including those reasons set forth in the Rules. If the Agreement is terminated during a Session, the Client shall reimburse Miss R for any remaining costs or expenses incurred by Miss R for her services or the Equipment.

8 - The Client shall make the appropriate mutually agreed upon donation to Miss R for cancellations less than twenty-four (24) hours prior to a scheduled Session. In addition, should any Equipment become broken, lost or malfunctions during a Session, the Client shall reimburse Miss R for the disposal and replacement costs.

9 - Miss R and the Client will abide by all safety provisions set forth in the Rules for Session. The Client shall disclose to Miss R any and all physical, psychological and medical conditions which could potentially jeopardize their safety during a Session by honestly completing the pre-Session Questionnaire which contains a medical disclosure form. The Client will also verbally disclose to Miss R prior to each Session, any change in the Client's physical or medical condition which could potentially jeopardize the health or physical safety of the Client or Miss R. Miss R retains the right to terminate a Session and/or this Agreement immediately upon discovery or disclosure of any information which could potentially cause physical, medical or psychological harm to either party. Neither the Client nor their heirs or assigns, will hold Miss R liable for any physical, medical or psychological injuries sustained during or subsequent to a Session.

10 - The Client understands that alcohol and recreational drugs are absolutely prohibited during the Session. If the Client violates this provision by arriving at a Session under the influence of alcohol and/or recreational drugs, this Agreement and/or the Session will be terminated immediately with full payment made to Miss R of the mutually agreed upon donation and any reimbursement for any costs and/or expenses incurred by Miss R. This also holds sway for Doctor Proscribed Pharmaceuticals that may inhibit the Client's mental, emotional or physical state while in a Session.

11 - Miss R may amend this Agreement at any time without notice.

12 - The terms and conditions of this Agreement are binding on the Client's heirs and assigns.

13 - Miss R desires that the Client find her services and Techniques to be beneficially artistic, therapeutic and educational. If the Client is dissatisfied with a Session, the Client may discuss this with Miss R and She will attempt to provide future services and Techniques that are more to the Client's satisfaction, assuming they meet the requirements of this Agreement and the Rules. However, Miss R does not guarantee that Her services will meet every Client's satisfaction. The failure of Miss R to provide the Client with satisfactory services does not constitute a breach of this Agreement. Under no condition will Miss R return a donation or reimbursement of costs and expenses to any Client for dissatisfaction with Her services or any other reason. The Client should take notice that any breach of this Agreement or the Rules by the Client may result in Legal action (e.g., unauthorized disclosure of Miss R's identity). The Damages Recoverable by Miss R under the terms and conditions of this Agreement include actual, consequential and punitive damages.

The Client has read this Agreement and the Rules of Session and has honestly completed the questionnaire. The Client understands and accepts all terms and conditions contained within these documents.
